WHAT DOES BENTLEY FORT LAUDERDALE & ROLLS ROYCE MOTOR CARS DO WITH YOUR PERSONAL INFORMATION?

WHY?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
WHAT?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and income. • Payment history and transaction or loss history. • Credit scores and employment information. When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.
HOW?	All financial companies need to share personal information to run their everyday business. In the section below, we list the reasons financial companies can share their personal information; the reasons Bentley Fort Lauderdale & Rolls Royce Motor Cars chooses to share; and whether you can limit this sharing.

Who is providing this notice? Bentley Fort Lauderdale & Rolls Royce Motor Cars

How does Bentley Fort Lauderdale & Rolls Royce Motor Cars protect my personal information? To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We restrict access to non-public personal information about you to those employees who need to know that information.

How does Bentley Fort Lauderdale & Rolls Royce Motor Cars collect my personal information? We collect your personal information, for example, when you
• Open an account or apply for a loan
• Provide income information or show us your driver's license
• Provide employment information
We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing? Federal law gives you the right to limit only
• sharing for affiliates' everyday business purposes - information about your creditworthiness
• affiliates from using your information to market to you
• sharing for non-affiliates to market to you
State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates Companies related by common ownership or control. They can be financial and non-financial companies.
• Our affiliates include companies with a common corporate identity with or owned by Holman Automotive Group, Inc. the parent company of Bentley Fort Lauderdale & Rolls Royce Motor Cars.

Non-affiliates Companies not related by common ownership or control. They can be financial and non-financial companies.
• Bentley Fort Lauderdale & Rolls Royce Motor Cars does not share with non-affiliates so they can market to you.

Joint Marketing A formal agreement between nonaffiliated financial companies that together market financial products or services you.
• Our joint marketing partners include other Holman Dealerships and affiliated companies, and non-affiliated finance companies.
